

Simplified DES, developed by Professor Edward Schaefer of Santa Clara University [SCHA96], is an educational rather than a secure encryption algorithm. It has similar properties and structure to DES with much smaller parameters. The reader might find it useful to work through an example by hand while following the discussion in this Appendix.

## C. 1 Overview

Figure C. 1 illustrates the overall structure of the simplified DES, which we will refer to as SDES. The S-DES encryption algorithm takes an 8-bit block of plaintext (example: 10111101) and a 10 -bit key as input and produces an 8 -bit block of ciphertext as output. The S-DES decryption algorithm takes an 8-bit block of ciphertext and the same 10-bit key used to produce that ciphertext as input and produces the original 8-bit block of plaintext.

The encryption algorithm involves five functions: an initial permutation (IP); a complex function labeled $\mathrm{f}_{K}$, which involves both permutation and substitution operations and depends on a key input; a simple permutation function that switches (SW) the two halves of the data; the function $\mathrm{f}_{K}$ again; and finally a permutation function that is the inverse of the initial permutation ( $\mathrm{IP}^{-1}$ ). As was mentioned in Chapter 2, the use of multiple stages of permutation and substitution results in a more complex algorithm, which increases the difficulty of cryptanalysis.

The function $\mathrm{f}_{K}$ takes as input not only the data passing through the encryption algorithm, but also an 8-bit key. The algorithm could have been designed to work with a 16 -bit key, consisting of two 8-bit subkeys, one used for each occurrence of $\mathrm{f}_{K}$. Alternatively, a single 8-bit key could have been used, with the same key used twice in the algorithm. A compromise is to use a 10 -bit key from which two 8 -bit subkeys are generated, as depicted in Figure C.1. In this case, the key is first subjected to a permutation (P10). Then a shift operation is performed. The output of the shift operation then passes through a permutation function that produces an 8-bit output (P8) for the first subkey $\left(K_{1}\right)$. The output of the shift operation also feeds into another shift and another instance of P8 to produce the second subkey $\left(K_{2}\right)$.

We can concisely express the encryption algorithm as a composition ${ }^{1}$ of functions:

$$
\mathrm{IP}^{-1} \circ \mathrm{f}_{K_{2}} \circ \mathrm{SW} \circ \mathrm{f}_{K_{1}} \circ \mathrm{IP}
$$

which can also be written as:

$$
\text { ciphertext }=\operatorname{IP}^{-1}\left(\mathrm{f}_{K_{2}}\left(\mathrm{SW}\left(\mathrm{f}_{K_{1}}(\operatorname{IP}(\text { plaintext }))\right)\right)\right)
$$

where

$$
\begin{aligned}
& K_{1}=\mathrm{P} 8(\operatorname{Shift}(\operatorname{P10}(\text { key }))) \\
& K_{2}=\mathrm{P} 8(\operatorname{Shift}(\operatorname{Shift}(\operatorname{P10}(\text { key }))))
\end{aligned}
$$

Decryption is also shown in Figure C. 1 and is essentially the reverse of encryption:

$$
\text { plaintext }=\operatorname{IP}^{-1}\left(\mathrm{f}_{K_{1}}\left(\mathrm{SW}\left(\mathrm{f}_{K_{2}}(\operatorname{IP}(\text { ciphertext }))\right)\right)\right)
$$

1 Definition: If f and g are two functions, then the function F with the equation $\mathrm{y}=\mathrm{F}(x)=$ $\mathrm{g}[\mathrm{f}(x)]$ is called the composition of f and g and is denoted as $\mathrm{F}=\mathrm{g} \circ \mathrm{f}$.

We now examine the elements of S-DES in more detail.

## C. 2 S-DES Key Generation

S-DES depends on the use of a 10-bit key shared between sender and receiver. From this key, two 8-bit subkeys are produced for use in particular stages of the encryption and decryption algorithm. Figure C. 2 depicts the stages followed to produce the subkeys.

First, permute the key in the following fashion. Let the 10 -bit key be designated as ( $k_{1}, k_{2}$, $\left.k_{3}, k_{4}, k_{5}, k_{6}, k_{7}, k_{8}, k_{9}, k_{10}\right)$. Then the permutation P 10 is defined as:

$$
\operatorname{P} 10\left(k_{1}, k_{2}, k_{3}, k_{4}, k_{5}, k_{6}, k_{7}, k_{8}, k_{9}, k_{10}\right)=\left(k_{3}, k_{5}, k_{2}, k_{7}, k_{4}, k_{10}, k_{1}, k_{9}, k_{8}, k_{6}\right)
$$

P10 can be concisely defined by the display:

| P 10 |  |  |  |  |  |  |  |  |  |

| 3 | 5 | 2 | 7 | 4 | 10 | 1 | 9 | 8 | 6 |

This table is read from left to right; each position in the table gives the identity of the input bit that produces the output bit in that position. So the first output bit is bit 3 of the input; the second output bit is bit 5 of the input, and so on. For example, the key (1010000010) is permuted to (1000001100). Next, perform a circular left shift (LS-1), or rotation, separately on the first five bits and the second five bits. In our example, the result is (00001 11000).

Next we apply P8, which picks out and permutes 8 of the 10 bits according to the following rule:

| 6 | 3 | 7 | 4 | 8 | 5 | 10 | 9 |

The result is subkey $1\left(K_{1}\right)$. In our example, this yields (10100100)
We then go back to the pair of 5-bit strings produced by the two LS- 1 functions and perform a circular left shift of 2 bit positions on each string. In our example, the value (00001 $11000)$ becomes $(0010000011)$. Finally, P8 is applied again to produce $K_{2}$. In our example, the result is (01000011).

## C. 3 S-DES Encryption

Figure C. 3 shows the S-DES encryption algorithm in greater detail. As was mentioned, encryption involves the sequential application of five functions. We examine each of these.

## Initial and Final Permutations

The input to the algorithm is an 8-bit block of plaintext, which we first permute using the IP function:

This retains all 8 bits of the plaintext but mixes them up. At the end of the algorithm, the inverse permutation is used:

| $\mathrm{IP}^{-1}$ |  |  |  |  |  |  |  |
| :--- | :--- | :--- | :--- | :--- | :--- | :--- | :--- |
| 4 | 1 | 3 | 5 | 7 | 2 | 8 | 6 |

It is easy to show by example that the second permutation is indeed the reverse of the first; that is, $\operatorname{IP}^{-1}(\operatorname{IP}(X))=X$.

## The Function $\mathrm{f}_{K}$

The most complex component of S-DES is the function $\mathrm{f}_{K}$, which consists of a combination of permutation and substitution functions. The functions can be expressed as follows. Let $L$ and $R$ be the leftmost 4 bits and rightmost 4 bits of the 8 -bit input to $\mathrm{f}_{K}$, and let F be a mapping (not necessarily one to one) from 4-bit strings to 4 -bit strings. Then we let

$$
\mathrm{f}_{K}(L, R)=(L \oplus \mathrm{~F}(R, S K), R)
$$

where $S K$ is a subkey and $\oplus$ is the bit-by-bit exclusive-OR function. For example, suppose the output of the IP stage in Figure C. 3 is $(10111101)$ and $\mathrm{F}(1101, S K)=(1110)$ for some key $S K$. Then $\mathrm{f}_{K}(10111101)=(01011101)$ because $(1011) \oplus(1110)=(0101)$.

We now describe the mapping F. The input is a 4-bit number $\left(n_{1} n_{2} n_{3} n_{4}\right)$. The first operation is an expansion/permutation operation:

For what follows, it is clearer to depict the result in this fashion:

The 8 -bit subkey $K_{1}=\left(k_{11}, k_{12}, k_{13}, k_{14}, k_{15}, k_{16}, k_{17}, k_{18}\right)$ is added to this value using exclusiveOR:

$$
\begin{array}{l|ll|l}
n_{4} \oplus k_{11} & n_{1} \oplus k_{12} & n_{2} \oplus k_{13} & n_{3} \oplus k_{14} \\
n_{2} \oplus k_{15} & n_{3} \oplus k_{16} & n_{4} \oplus k_{17} & n_{1} \oplus k_{18}
\end{array}
$$

Let us rename these 8 bits:

$$

The first 4 bits (first row of the preceding matrix) are fed into the $S$-box $S 0$ to produce a 2bit output, and the remaining 4 bits (second row) are fed into S 1 to produce another 2-bit output. These two boxes are defined as follows:

The S-boxes operate as follows. The first and fourth input bits are treated as a 2-bit number that specify a row of the S-box, and the second and third input bits specify a column of the Sbox. The entry in that row and column, in base 2 , is the 2 -bit output. For example, if ( $p_{0,0} p_{0,3}$ ) = $(00)$ and $\left(p_{0,1} p_{0,2}\right)=(10)$, then the output is from row 0 , column 2 of $S 0$, which is 3 , or (11) in binary. Similarly, ( $p_{1,0} p_{1,3}$ ) and ( $p_{1,1} p_{1,2}$ ) are used to index into a row and column of S1 to produce an additional 2 bits.

Next, the 4 bits produced by S 0 and S 1 undergo a further permutation as follows:

| P 4 |  |  |  |
| :---: | :---: | :---: | :---: |
| 2 | 4 | 3 | 1 |

The output of P 4 is the output of the function F .

## The Switch Function

The function $\mathrm{f}_{K}$ only alters the leftmost 4 bits of the input. The switch function (SW) interchanges the left and right 4 bits so that the second instance of $\mathrm{f}_{K}$ operates on a different 4 bits. In this second instance, the $\mathrm{E} / \mathrm{P}, \mathrm{S} 0, \mathrm{~S} 1$, and P 4 functions are the same. The key input is $K_{2}$.

## C. 4 Analysis of Simplified DES

A brute-force attack on simplified DES is certainly feasible. With a 10 -bit key, there are only $2^{10}$ $=1024$ possibilities. Given a ciphertext, an attacker can try each possibility and analyze the result to determine if it is reasonable plaintext.

What about cryptanalysis? Let us consider a known plaintext attack in which a single plaintext ( $p_{1}, p_{2}, p_{3}, p_{4}, p_{5}, p_{6}, p_{7}, p_{8}$ ) and its ciphertext output ( $c_{1}, c_{2}, c_{3}, c_{4}, c_{5}, c_{6}, c_{7}, c_{8}$ ) are known and the key ( $k_{1}, k_{2}, k_{3}, k_{4}, k_{5}, k_{6}, k_{7}, k_{8}, k_{9}, k_{10}$ ) is unknown. Then each $c_{i}$ is a polynomial function $\mathrm{g}_{i}$ of the $p_{j}^{\prime} \mathrm{s}$ and $k_{j}^{\prime} \mathrm{s}$. We can therefore express the encryption algorithm as 8 nonlinear equations in 10 unknowns. There are a number of possible solutions, but each of these could be calculated and then analyzed. Each of the permutations and additions in the algorithm is a linear mapping. The nonlinearity comes from the S-boxes. It is useful to write down the equations for these boxes. For clarity, rename $\left(p_{0,0}, p_{0,1}, p_{0,2}, p_{0,3}\right)=(a, b, c, d)$ and $\left(p_{1,0}, p_{1,1}, p_{1,2}, p_{1,3}\right)=(w, x$, $y, z$ ), and let the 4 -bit output be ( $q, r, s, t$ ) Then the operation of the S 0 is defined by the following equations:

$$
\begin{aligned}
& q=a b c d+a b+a c+b+d \\
& r=a b c d+a b d+a b+a c+a d+a+c+1
\end{aligned}
$$

where all additions are modulo 2 . Similar equations define S1. Alternating linear maps with these nonlinear maps results in very complex polynomial expressions for the ciphertext bits, making cryptanalysis difficult. To visualize the scale of the problem, note that a polynomial equation in 10 unknowns in binary arithmetic can have $2^{10}$ possible terms. On average, we might therefore
expect each of the 8 equations to have $2^{9}$ terms. The interested reader might try to find these equations with a symbolic processor. Either the reader or the software will give up before much progress is made.

## C. 5 Relationship to DES

DES operates on 64-bit blocks of input. The encryption scheme can be defined as:

$$
\mathrm{IP}^{-1} \circ \mathrm{f}_{K_{16}} \circ \mathrm{SW} \circ \mathrm{f}_{K_{15}} \circ \mathrm{SW} \circ \cdots \circ \mathrm{SW} \circ \mathrm{f}_{K_{1}} \circ \mathrm{IP}
$$

A 56-bit key is used, from which sixteen 48-bit subkeys are calculated. There is an initial permutation of 64 bits followed by a sequence of shifts and permutations of 48 bits.

Within the encryption algorithm, instead of F acting on 4 bits $\left(n_{1} n_{2} n_{3} n_{4}\right)$, it acts on 32 bits $\left(n_{1} \ldots n_{32}\right)$. After the initial expansion/permutation, the output of 48 bits can be diagrammed as:


This matrix is added (exclusive-OR) to a 48 -bit subkey. There are 8 rows, corresponding to 8 S-boxes. Each S-box has 4 rows and 16 columns. The first and last bit of a row of the preceding matrix picks out a row of an S-box, and the middle 4 bits pick out a column.
